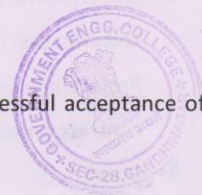

9. Payment shall be made in Indian Rupees as follows:



- Digester & Gas holder (Up flow anaerobic sludge blanket reactor type) made of HDPE with minimum thickness of  $10 \pm 2$  mm
- Inlet pipe (minimum 4 inch dia) for feeding with crusher of appropriate capacity.
- Water removal chamber.
- Outlet pipe and gas transmission system.
- Appropriate Gas flow meter
