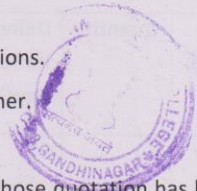

1	Library Cup Board (Book case type)	The unit should be made from 1 mm thick MS CRCA sheet Confirming to IS 513 / 1994 , grade 0 with having size 1680 ± 5 mm (Height) x 840 ± 5 mm (Width) x 310 ± 5 mm (Depth) with 4 compartment overhung sliding door & remaining all 0.8 mm thickness, with 4 mm thick transparent glass in the door. Complete powder coated with pretreatment & phosphatizing treatment before powder coating. All the sheet cutting and bending work on machine base. Lock and handle selection is right for the Purchaser. Poor workmanship may be one of the reason to reject the sample and goods
2	Steel Filing Cabinet	The unit should be made from 1 mm thick MS CRCA sheet Confirming to IS 513 / 1994 , grade 0 with having size 470 ± 5 mm (width) by 620 ± 5 mm (depth) by 1320 ± 5 mm (height) including pedestal with 4 equal sized Drawer which plastic molded handle inbuilt into the drawer with frictionless rollers with central lock of six lever as per IS-729, keys should not be interchangeable. Pedestal height should be 65± 2mm. Powder Coated unit with grey shade . Poor workmanship may be one of the reason to reject the sample and goods
